It is also open to all natural and legal persons established in a third country which has a special agreement with the European Union in the field of public procurement on the conditions laid down in that agreement. Where the Agreement on Government Procurement concluded within the World Trade Organisation applies, the participation to this call for tenders is open to all natural and legal persons established in the countries that have ratified this Agreement, on the conditions laid down therein." Nevertheless, as stated in the contract notice (section IV.1.8), EU-OSHA as regulatory Agency does not apply the GPA. Therefore, economic operators established in third countries (the UK included) are not eligible.
