- 4. Tenders must be submitted as follows:
 - a) One signed original and two copies of your tender must be placed inside two sealed envelopes (one inside the other). The outer and inner envelope, addressed to the department indicated in the invitation to tender, should be marked as follows: 'Invitation to tender Not to be opened by the internal mail department', indicating the company name and tender reference number (see example below). If self-adhesive envelopes are used, they must be sealed with adhesive tape and the sender must sign across the tape.

Each envelope must be marked as follows (<u>failure to do so could result in the exclusion of your offer</u>):

- 5. The specifications for this contract and the draft contract are enclosed with this invitation to tender. The specifications list the documents that must be produced in order to submit a tender, including supporting evidence of economic, financial, technical and professional capacity and the exclusion criteria.
- 6. All tenders must be:
 - signed by the tenderer or his duly authorised representative;
 - perfectly legible so that there can be no doubt as to words and figures;
 - drawn up using the model reply forms in the specifications.
- 7. Period of validity of the tender, during which tenderers may not modify the terms of their tenders in any respect: 12 months from the final date for submission.
- 8. Submission of a tender implies acceptance of all the terms and conditions set out in this invitation to tender, in the specification and in the draft contract and, where appropriate,

waiver of the tenderer's own general or specific terms and conditions. It is binding on the tenderer to whom the contract is awarded for the duration of the contract.

- 9. Contacts between the contracting authority and tenderers are prohibited throughout the procedure save in exceptional circumstances and under the following conditions only:
 - i) <u>Before the final date for submission of tenders</u>: at the request of the tenderer, the contracting authority may provide additional information solely for the purpose of clarifying the nature of the contract.

Requests for additional information received less than <u>five working days</u> before the final date for submission of tenders will not be processed.

ii) After the opening of tenders:

If clarification is required or if obvious clerical errors in the tender need to be corrected, the contracting authority may contact the tenderer provided that the terms of the tender are not modified as a result.

- 10. This invitation to tender is in no way binding upon the Commission. The Commission's contractual obligation commences only upon signature of the contract with the successful tenderer.
- 11. Up to the point of signature, the contracting authority may either abandon the procurement or cancel the award procedure, without the candidates or tenderers being entitled to claim any compensation. This decision must be substantiated and the candidates or tenderers notified.
- 12. Once the Commission has opened the tender, the document shall become the property of the Commission and it shall be treated confidentially.
- 13. You will be informed whether or not your tender has been accepted

- 14. If your offer includes subcontracting, it is recommended that contractual arrangements with subcontractors include mediation as a method of dispute resolution.
